FAMILY LAW FELLOWSHIP COURSE

The Institute of Law Clerks of Ontario "ILCO" is pleased to offer the Family Law Fellowship course to its members and to the legal community.

The course will cover all of the major areas of Family Law including: who is a family and why the government regulates families; the constitutional and institutional contexts of family law and the Family Law Rules; common law relationships, marriage and divorce; equalization of matrimonial property, financial statements and financial disclosure; support under the Child Support Guidelines including special and extraordinary expenses and under the Spousal Support Advisory Guidelines, and the formation, variation and setting aside of Domestic Contracts.

The course instructor is E. Llana Nakonechny, LL.M., a partner of the all woman firm of Dickson MacGregor Appell LLP in Toronto. Ms. Nakonechny holds a Bachelor of Fine Arts from Brock University (1982), an LL.B. from the University of Ottawa (1985) and an LL.M. in International Protection of Human Rights from the University of Essex, England (1987). She was called to the Ontario Bar in 1988. Ms. Nakonechny has been an instructor in Family Law at the Bar Admission Course and at Ryerson Polytechnic University. She has lectured in Ensemble Acting at Concordia University's Faculty of Fine Arts in Montreal. Currently, she is a part time professor at the University of Ottawa, Faculty of Common Law, teaching family law and civil procedure.

A background in Family Law is **highly recommended** for this course. Students will be evaluated on the basis of a mid term take home problem worth 20% of the final grade and a final in class exam worth 80% of the final grade. The exam may include drafting of pleadings and income or property calculations.
